Building eConsult into your Referral Workflow The Delegate Model



What is eConsult?

eConsult is a secure web-based tool that allows physicians and nurse practitioners timely access to specialist advice for all patients, often eliminating the need for an in-person specialist visit. eConsult allows for improved access to specialty care for patients (with a median response time ~ 1 day)

What is a delegate?

- A delegate is someone who can create, submit, manage, monitor and file eConsults on behalf of one or many physicians or nurse practitioners
- A delegate is typically a referral clerk, nurse or administrator working within the physician or nurse practitioner's clinic or centre who has access to a patient's PHI
- A delegate supports clinical workflow where eConsult is not integrated with a provider's EMR

Advantages of the Delegate Model

- Improved workflow for front line primary care providers, by utilizing administrative support to manage eConsult workflow in non-integrated EMR settings
- Improved information flow, managed by delegates, ensuring timely management of patient-related inquiries
- Providers and delegates can build upon existing clinical best practices to incorporate eConsult into their workflow

Delegate Model Workflow



- Makes the decision to send an eConsult request
- Notes/creates the question for the specialist in the EMR
- Selects the pertinent patient (chart) information to accompany the eConsult
- · Notifies the delegate of the need to submit the eConsult request, on their behalf
- Reviews the specialist response
- Determines if further information/follow up is required, based on the specialist response
- Advises the delegate when the case is resolved or requires further action
- Responds to the closeout survey questions for the case to be completed
- Follow-up with patient and action specialist advice

Delegate

- Receives the provider's request to initiate the eConsult
- Saves a (local) PDF copy of the patient information to be attached to the eConsult request (& deletes it from the local storage afterwards)
- Logs in to eConsult platform to submit the eConsult, on the provider's behalf
- Copies the provider's question & attaches all pertinent information (including patient details), to the eConsult request
- Submits the eConsult
- Monitors email for notification of specialist response
- Copies the specialist response (once received), into the EMR for the provider to review (& notifies the provider)
- Submits a follow up question, to the specialist, on the eConsult platform (where required)
- Closes out the case with the provider's survey responses, on eConsult platform

Is the Delegate Model Right for Me?

- ✓ I have administrative personnel in place who already assist with the outgoing referral work in my clinic
- ✓ I would like to be able to have my non-urgent patient inquiries addressed in a timely manner with less administrative burden to me
- ✓ I would like to leverage the support of my staff to assist me with the administrative tasks of submitting an eConsult

What do I need to do to implement this in my clinic?

- Complete a full needs analysis and develop a workflow plan
- Identify staff who will be involved in establishing the eConsult delegate process into your clinic: physicians, referral clerks and/or administrative staff (ie. Delegates)
- Discuss any privacy considerations and develop strategies to ensure PHI is only visible to appropriate personnel.
- Ensure all personnel are set up with the necessary accounts.
- Set up new workflow into existing systems (ie. EMR) and complete administrative set up
- Train all personnel involved on the workflow

Tools and Processes

- Encounter Assistant to complete Closeout Survey (if using)
- Encounter Assistant to automate processes, including template to pull information from PSS and link to eConsult page for quicker data entry
- Initiating the Pending Test or Consult tracker (if using)
- Initiating a letter
- Adding eConsult Platform launch page to Resource section in PSS
- Stamps to create letter templates (if using)
- SuperCode to bill K738 with other billing codes (if required)
